#### **RESOLUTION NO. 623-2024**

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2024 OF MANAOAG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P240,000,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2024 involving total appropriations of P240,000,000.00, which was enacted on March 26, 2024 through Appropriation Ordinance No. 01, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding source for the subject Supplemental Budget was determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

- 2. That the total fund source available for supplemental appropriation (i.e. Proceeds from Loan from the Land Bank of the Philippines (LBP) will be made actually available as required under Article 417 (a) of the IRR of R.A. 7160, as amended by Administrative Order No. 47, and as contained in the Omnibus Term Loan Agreement between the LBP and the municipal government of Manaoag;
- 3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007; and
- 4. That all procurements to be undertaken shall be subject to provisions of RA. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 1 for Calendar Year 2024 of Manaoag, Pangasinan;
