RESOLUTION NO. 625-2024

DECLARING MUNICIPAL ORDINANCE NO. 14, S-2023 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “ESTABLISHING THE BATCH REQUEST QUERY SYSTEM (BREQS) OF THE MUNICIPALITY OF MANAOAG, PANGASINAN DEFINING ITS PURPOSE, IMPOSING CHARGES OR FEES FOR SERVICES THEREOF AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Municipal Ordinance No. 14, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 22, (a) (c), 129, 132, 447 (a) (3) (i) & 465 (vi) of R.A. No. 7160; and Philippine Statistics Authority’s Batch Request System (BREQS) Scheme;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 14, S-2023 of the Sangguniang Bayan of Manaoag, Pangasinan, entitled “Establishing the Batch Request Query System (BREQS) of the Municipality of Manaoag, Pangasinan defining its purpose, imposing charges or fees for services thereof and for other purposes” as within the conferred powers of the Sangguniang Bayan to enact;


