**RESOLUTION NO. 627-2024**

**APPROVING RESOLUTION NO. 30, S-2024 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "APPROVING THE 2024 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 AND OTHER ACTIVITIES RELATED TO THE SUPPLEMENTAL BUDGET NO. 1 FUNDS IN THE AMOUNT OF ONE HUNDRED SIX MILLION THREE HUNDRED SIXTY NINE THOUSAND SEVENTY SIX PESOS AND 13/100 CENTAVOS (P106,369,076.13) OF THE MUNICIPALITY OF VILLASIS, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 30, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Villasis, Pangasinan has identified items in their Supplemental Annual Investment Program No.1. This was endorsed to the Sangguniang Bayan for approval on March 7, 2024 by the Municipal Development Council-Executive Committee through Resolution No. 01-2024;

2. The SAIP covers fund augmentation for the Personal Services (granting of incentive/bonuses and other personnel benefits), implementation of disaster risk reduction program, development projects of the LGU and other projects in support to the tobacco growing farmers in the LGU;
3. The projects proposed to be funded from the tobacco excise tax are in accordance with the CY 2021 Collection of Burley and Native Tobacco Excise Tax under RA No. 8240, as Amended, Chargeable against the FY 2023 GAA, RA No. 11936; and
4. Funding support for the full implementation of the same in the amount of Php 106,369,076.13 is embodied in their proposed Supplemental Budget No.1 for CY 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 01 on March 25, 2024.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Villasis, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


