RESOLUTION NO. 628-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2024 OF VILLASIS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P106,369,076.13, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2024 involving total appropriations of P106,369,076.13, which was enacted on March 25, 2024 through Appropriation Ordinance No. 01, Calendar Year 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
- That all programs, projects and activities to be implemented are in accordance with the approved CY 2024 Annual Investment Program of the Municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF JMC No. 1, Series of 2007 dated March 8, 2007;

- 3. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
- 4. That the utilization of appropriations from CY 2021 shares of the Municipality from Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum No. 89 dated November 10, 2023;
- 5. That the grant of Clothing Allowance to all municipal officials and employees of the municipality for Fiscal Year 2024 shall be in accordance with the provisions of Budget Circular 2024-01 dated April 4, 2024 of the Department of Budget and Management; and
- That the grant of Service Recognition Incentive (SRI) and Performance-Based Bonus (PBB) for Calendar Year 2024 shall only be disbursed upon issuance of circulars granting the same.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 1 for Calendar Year 2024 of Villasis, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Villasis, Pangasinan, for its information and guidance.
