RESOLUTION NO. 630-2024

DECLARING MUNICIPAL ORDINANCE NO. 193-250324 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “SHALL BE KNOWN AS “THE VILLASIS CHILDREN’S CODE OF 2024” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 193-250324 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with the United Nations Convention on the Rights of the Child (CRC); Republic Act No. 7610 of 1992 (Special Protection of Children Against Child Abuse, Exploitation, and Discrimination Act) otherwise known as the “Children Protection Law”; Presidential Decree No. 603 (The Child and Youth Welfare Code) and Sections 17 (b) (2) (iii) (iv) (5) and (xiv) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan., duly seconded, it was—


