**DECLARING ORDINANCE NO. 2024-08 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING THE POSITION TITLE OF SUPERVISING LABOR AND EMPLOYMENT OFFICER (SG 22/1) AND CREATING THE POSITION TITLE OF ADMINISTRATIVE AIDE VI (CLERK III) (SG 6/1) AND TWO (2) ADMINISTRATIVE AIDE III (AUDIO-VISUAL EQUIPMENT OPERATOR I) (SG 3/1) UNDER THE PUBLIC EMPLOYMENT SERVICE OFFICE” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**




