**WHEREAS**, the Professional Regulation Commission along with the Professional Regulatory Board for Teachers conducted the Special Professional Licensure Examination for Professional Teachers - Elementary on June 2024;

**WHEREAS**, a total of 137 elementary teachers out of 274 examinees (50.00%) successfully passed the Special Professional Licensure Examination for Professional Teachers- Elementary in: Abu Dhabi and Dubai, United Arab Emirates; Al Ahmadi, Kuwait; Al-Khobar, Jeddah and Riyadh, Kingdom of Saudi Arabia; Doha, Qatar; Manama, Bahrain; and Singapore;

**WHEREAS**, Ms. Bacani is a native of Basista, Pangasinan who secured the eight spot (Top 8) in the said licensure examination with a score of 84.20%;


