**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR
CALENDAR YEAR 2024 OF STA. BARBARA, PANGASINAN
INVOLVING A TOTAL APPROPRIATION OF P34,126,030.00,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Supplemental Budget No. 2024-02 for Calendar Year 2024 involving total appropriations of Php34,126,030.00 which was enacted on March 26, 2024 through Appropriation Ordinance No. 2024-038, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its Supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;

2. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
4. That the disbursement of additional One Thousand Pesos (P1,000.00) for Uniform/Clothing Allowance shall be subject to DBM Budget Circular No. 2024-1 dated April 4, 2024;
5. That the employer (government) share in the premium contributions to the Home Development Mutual Fund (PAG-IBIG FUND) of municipal officials and employees shall be in accordance with the provisions of DBM Circular Letter No. 2024-2 dated February 1, 2024;
6. That the utilization of appropriation from FY 2021 share of the Municipality from Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum No. 86 dated December 14, 2022; and
7. That the purchase of motor vehicle shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022 re “Omnibus Guidelines on the Acquisition, Use, Rental and Replacement of Government Motor Vehicles” & Budget Circular No. 2022-1A dated March 1, 2023, (Supplemental Guidelines on the Acquisition, Use, Rental & Replacement of Government Motor Vehicles);

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 2 for Calendar Year 2024 of Sta. Barbara, Pangasinan;


