**APPROVING RESOLUTION NO. 52-S-2024 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL AIP NO. 1 CY 2024 OF THE LOCAL GOVERNMENT UNIT OF SAN FABIAN, PANGASINAN AMOUNTING TO P24,578,985.00”**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 52-S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of San Fabian, Pangasinan prepared the LGU’s Supplemental Annual Investment Program (SAIP) No. 1 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 01-S 2024 dated May 13, 2024, to the Sangguniang Bayan for approval;
2. Said Supplemental AIP, which has a total investment requirement of P24,578,985.00, covers the implementation of municipal projects for tobacco-growing farmers of San Fabian. The projects proposed to be funded from the share of the LGU on Tobacco Excise Tax, CY-2021 conform with Local Budget Memorandum No. 89 dated November 10, 2023 of the DBM (Guidelines on the Release and Utilization of the Shares of Local Government Units from the FY 2021 and Prior Years’ Collection of Excise Tax...); and




