RESOLUTION NO. 664-2024

DECLARING MUNICIPAL TAX ORDINANCE NO. 2023-02 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE ENACTING THE UPDATED MARKET CODE OF THE MUNICIPALITY OF ALCALA, PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Tax Ordinance No. 2023-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Acting Provincial Treasurer have conducted initial review and study on said municipal tax ordinance and found out that the same was enacted in accordance with Sections 444 (a) (b) (1) (ix) & 447 (3) (i) (iii) (5) (ii) of R. A. No. 7160 and Articles 20 & 22 of the R. A. No. 7394 or “The Consumer Act of the Philippines”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to 188 of R.A. No. 7160;


