APPROVING RESOLUTION NO. 225-06102024 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “RESOLUTION ADOPTING THE COMPREHENSIVE LAND USE PLAN (CLUP) OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN FOR THE YEAR 2023-2033 (VOLUME I) AND ITS SECTORAL STUDIES (VOLUME 3)”

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 225-06102024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer and the Provincial Land Use Committee have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (2) (viii) of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Comprehensive Land Use Plan (CLUP) of Pozorrubio, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Memorandum Circular No. 2000-130 of the Department of the Interior and Local Government as embodied in Section 2 (b) of Executive Order No. 72, S-1993;

WHEREAS, the PLUC certified that the Municipality had incorporated in the final draft its recommendations and suggestions;


