RESOLUTION NO. 668-2024

DECLARING MUNICIPAL ORDINANCE NO. 07-06102024 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE ENACTING THE ZONING REGULATIONS OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN AND PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT THEREWITH” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 07-06102024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer, and the Provincial Land Use Committee (PLUC) have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (2) (ix) of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Zoning Ordinance of Pozorrubio, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Memorandum Circular No. 2000-130 of the Department of the Interior and Local Government as embodied in Section 2 (b) of Executive Order No. 72, S-1993;

WHEREAS, the PLUC found the Zoning Ordinance of Pozorrubio, Pangasinan to be in conformity with the existing Land Use Planning Guidelines, Laws and Regulations and other development plans of the Province;


