PROVINCIAL RESOLUTION NO. 674-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A DEED OF DONATION AND ACCEPT A FINANCIAL ASSISTANCE FROM THE OFFICE OF THE PRESIDENT, FERDINAND R. MARCOS, JR. IN THE AMOUNT OF FORTY-EIGHT MILLION SEVEN HUNDRED SIXTY THOUSAND PESOS (PHP48,760,000.00)

WHEREAS, the El Niño phenomenon has brought below-normal rainfall condition that is causing prolonged dry spell and drought conditions in various parts of the country;

WHEREAS, the prolonged dry spell and drought conditions have led to enormous agricultural damage and water shortages and have adversely affected farmers and fisherfolks as well as the vulnerable and marginalized segments of the society;

WHEREAS, there is a need to extend assistance to these farmers, fisherfolks and marginalized households severely affected by El Niño to alleviate their plight and help them cope with the challenges in this trying time;

WHEREAS, the Province of Pangasinan has been at the forefront in responding to various calamities affecting the province and its constituents and will be the recipient of a financial assistance from the Office of the President, Ferdinand R. Marcos, Jr., in the amount of Forty-Eight Million Seven Hundred Sixty Thousand Pesos (Php48,760,000.00);

WHEREAS, the Province hereby expresses its gratitude and willingness to accept the said financial assistance;

WHEREAS, the said donation shall be used as cash assistance to farmers, fisherfolk and other marginalized families/households severely affected by El Niño to be determined by the provincial government and representatives of the Regional Field Units (RFUs) of the Department of Agriculture (DA) and the Department of Social Welfare and Development (DSWD) within the Province of Pangasinan;


WHEREAS, for the above purpose, a Deed of Donation shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Office of the President, represented by Undersecretary Al-Azree J. Mohammadsali;

NOW, THEREFORE, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was –


