RESOLUTION NO. 675-2024

APPROVING RESOLUTION NO. 098-2024 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "A RESOLUTION ENACTING SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 CALENDAR YEAR 2024 OF THE MUNICIPALITY OF AGNO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Resolution No. 098-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Agno, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 1 CY 2024. This was endorsed to the Sangguniang Bayan for approval on May 21, 2024 by the Municipal Development Council – Executive Committee through Resolution No. 01-2024;
2. Said SIP covers fund augmentation for Personal Services (adjustment of salaries and wages, step increments, and other personnel benefits), MOOE, and Capital Outlay of various municipal offices, and implementation of other development projects of the LGU; and

- Funding support for the implementation of the same in the amount of PhP13,565,340.14 is embodied in their proposed Supplemental Budget No. 1 for Calendar Year 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-01 on May 27, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Agno, Pangasinan;


