**RESOLUTION NO. 676-2024**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2024 OF AGNO, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF P13,565,340.14, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Agno, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2024 involving total appropriations of P13,565,340.14, which was enacted on May 27, 2024 through Appropriation Ordinance No. 2024-01;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the said supplemental budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all procurement to be undertaken shall be subject to the provisions of R.A No. 9184 (The Government Procurement Reform Act) and its Implementing Rules & Regulations;

3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
4. That the grant of Other Personnel Benefits- (Service Recognition Incentive) to qualified employees for Fiscal Year 2024 shall only be disbursed upon issuance of a circular granting the same;
5. That the grant of increase in Representation & Transportation Allowances (RATA) shall be in accordance with the provisions of Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management; and
6. The position title of the newly-created positions under the Office of the Mayor & the Office of the Vice Mayor shall be amended from Administrative Aide III, SG 4 to Administrative Aide IV- SG 4. Likewise, the parenthetical position title of Administrative Aide III (Clerk) SG 3 should be changed to Laborer II, to be consistent with the Ordinance creating the same.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez, and Raul R. Sabangan, duly seconded, it was—


**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 1 for Calendar Year 2024 of Agno, Pangasinan;
