**RESOLUTION NO. 682-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 48, S-2024 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED “AN ORDINANCE GRANTING LIFETIME LONGEVITY CASH INCENTIVES AMOUNTING TO THREE HUNDRED FIFTY PESOS (P350.00) MONTHLY TO EIGHTY-SIX (86) TO NINETY-NINE (99) YEARS OLD AGUILAREÑOS IN THE MUNICIPALITY OF AGUILAR, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Ordinance No. 48, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Republic Act No. 9994, otherwise known as “Expanded Senior Citizens Act of 2010”; Sections 17 (b) (2) (iv) & 447 (a) (5) (xvi) of R. A. No. 7160; and Article XV, Section 4 of the Philippine Constitution;

**WHEREAS**, it is now incumbent on the part of the Local Chief Executive in coordination of the Municipal Local Finance Committee to prepare a supplemental appropriation (Supplemental Budget) to allocate said amount for the implementation of the subject ordinance;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


