### RESOLUTION NO. 685-2024

**APPROVING RESOLUTION NO. 2024-59 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2024 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2024-59 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Disaster Risk Reduction Management Council of Mangaldan, Pangasinan, through MDRRM Council Resolution No. 1-2024, dated April 12, 2024, revised their MDRRM Plan CY 2024 to utilize the Unexpended Balances of MDRRM Fund/Trust Fund (CYs 2020-2023) of the LGU in the amount of P5,214,580.45;
2. The Municipal Development Council revised their AIP for CY 2024 to include new projects from the Revised MDRRM Plan of the LGU. This was endorsed by the Municipal Development Council, through MDC Resolution No. 01, Series of 2024 dated April 12, 2024, to the Sanggunian for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

The proposed projects except the procurement of 500 monobloc chairs, conform with NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund), and DILG-Memo-Circular No. 2023-065 dated April 25, 2023 (Mitigation and Preparedness Measures for the El Niño Phenomenon 2023); and
4. Likewise, the preparation of the Revised AIP is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote: The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


