APPROVING RESOLUTION NO. 2024-464 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 2, FOR THE CALENDAR YEAR 2024 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2024-464 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Balungao, Pangasinan had identified items in their Supplemental Annual Investment Program (SAIP) No.2 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on May 10, 2024 by the Municipal Development Council through Resolution No. 2024-02;
- 2. The SAIP No.2 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices of LGU Balungao; and

3. Funding support for the implementation of the same in the amount of PhP26,514,401.35 is embodied in their proposed Supplemental Budget No. 02 for Calendar Year 2024 which was enacted by their Sangguniang thru Appropriation Ordinance No. 2024-02 on June 3, 2024 and approved by the municipal mayor on June 7, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was–
