WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2024-33 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject Resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of San Manuel, Pangasinan has identified programs/projects in their Supplemental Investment Program (SIP) No.01. This was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 01, Series of 2024 dated April 19, 2024;
- 2. The Supplemental Investment Program No. 01 with a total investment requirement amounting to PhP7,069,270.78 covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and the implementation of various development programs and projects of LGU San Manuel; and
