**RESOLUTION NO. 702-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 5, S-2024 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED “AN ORDINANCE FOR THE RECLASSIFICATION OF PARCELS OF LAND FROM AGRICULTURAL TO COMMERCIAL LAND FOR SPECIAL USE AS A MEMORIAL PARK OF FOREST LAKE DEVELOPMENT, INC., IN THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN CONSISTING OF FIFTY FIVE THOUSAND (55,000) SQUARE METERS” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Municipal Ordinance No. 5, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Provincial Planning and Development Coordinator have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

**WHEREAS**, the requisite of public hearing has been complied with and nobody posed no objection on the reclassification of the subject land area;

**WHEREAS**, the Municipality of Mapandan has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan 2022-2032;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was –


