APPROVING MUNICIPAL RESOLUTION NO. 112-2024 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 01 SERIES OF 2024 OF THE MUNICIPALITY OF ANDA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Resolution No. 112-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Anda, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 01, Series of 2024. This was endorsed to the Sangguniang Bayan for approval on June 4, 2024 by the Municipal Development Council through MDC Resolution No. 02, Series of 2024;
- 2. Said SIP covers fund augmentation for Personal Services (adjustment of RATA and other personnel benefits of newly created positions) of the various municipal government offices of the LGU; and
- 3. Funding support for the implementation of the same in the amount of PhP1,320,901.75 is embodied in their proposed Supplemental Budget No. 1 for Budget Year 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2024 on June 18, 2024.
