RESOLUTION NO. 710-2024

APPROVING RESOLUTION NO. 53, S-2024 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1 OF THE MUNICIPALITY OF CALASIAO, PANGASINAN FOR THE YEAR 2024"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 53, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Calasiao, Pangasinan prepared the municipality's Supplemental Annual Investment Program No. 1 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 1, Series of 2024 dated March 14, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of P21,995,000.00, covers the augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE), and Capital Outlay (CO) of some municipal offices, and implementation of priority projects of the LGU; and

3. Funding for the SAIP is embodied in the LGU's Supplemental Budget No. 01, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 4, Series of 2024 dated June 3, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanila and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


