RESOLUTION NO. 712-2024

DECLARING MUNICIPAL ORDINANCE NO. 007, S-2023 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE NEW PERMANENT POSITIONS IN THE DIFFERENT OFFICES IN THE MUNICIPAL GOVERNMENT OF MALASIQUI, AS FOLLOWS: 1) LOCAL TREASURY OPERATIONS OFFICER III, SG-18; 2) LOCAL TREASURY OPERATIONS OFFICER II, SG-15, BOTH OFFICE OF THE TREASURY, 3) ADMINISTRATIVE AIDE III (UTILITY WORKER II), SG-3, OFFICE OF THE SANGGUNIANG BAYAN, 4) ADMINISTRATIVE AIDE II (UTILITY WORKER I), SG-2 IN THE OFFICE OF THE HEALTH SERVICES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Municipal Ordinance No. 007-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R. A. No. 7160;


