APPROVING RESOLUTION NO. 2024-78 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2024 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO THREE HUNDRED TWENTY-THREE MILLION FIVE HUNDRED FIFTY-TWO THOUSAND TWO HUNDRED THIRTY-NINE PESOS (P323,552,239.00)”

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2024-78 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Alaminos City, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 02, Series of 2024. This was endorsed to the Sangguniang Panlungsod for approval on April 18, 2024 by the City Development Council Executive Committee through Resolution No. 2024-01, Series of 2024;
2. Said SAIP contains the Acquisition of Lot (3 has.) for the Alaminos City College and the Construction of Alaminos City College Building with a total investment requirement of PhP323,552,239.00;

3. Funding support for the implementation of such will be sourced out from the reprogrammed project funded under the DBP Loan proceeds of the LGU amounting to PhP157,552,239.00. The reprogramming of which, emanated from CDC Execom Resolution No. 2024-02, Series of 2024 dated April 18, 2024. The remaining amount equivalent to PhP166,000,000.00 will be funded from another DBP Loan/borrowing of the LGU; and
4. It is humbly recommended that the LGU shall prepare Supplemental Budget once their loan is approved to support the full implementation of the identified projects in this subject Supplemental Investment Program.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of Alaminos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


