RESOLUTION NO. 719-2024

DECLARING MUNICIPAL ORDINANCE NO. 09-2024 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE FORTY EIGHT THOUSAND AND SEVENTEEN (48,017) SQ. M. PARCELS OF LAND FROM AGRICULTURAL TO SPECIAL USE PURPOSES LOCATED AT BARANGAY SAN RAMON, MANAOAG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Municipal Ordinance No. 09-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Coordinator have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the requisite of public hearing has been complied with and nobody posed no objection on the reclassification of the subject land area;

WHEREAS, the Municipality of Manaoag has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 1996-2005. Said CLUP and Zoning Ordinance, however, needs updating;

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Resolution No. 115, S-2024, entitled "Proposing the Reclassification of the Forty Eight Thousand and Seventeen (48,017) sq. m. parcels of land from agricultural to special use purposes located at Barangay San Ramon, Manaoag, Pangasinan, Registered Owner: Darius C. Tambaoan & Michael C. Tambaoan and Sps. Alberto G. Mangsat & Leonora Gutierrez-Mangsat";

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 09-2024 of the Sangguniang Bayan of Manaoag, Pangasinan, entitled "An Ordinance reclassifying the Forty Eight Thousand and Seventeen (48,017) sq. m. parcels of land from agricultural to special use purposes located at Barangay San Ramon, Manaoag, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
