PROVINCIAL RESOLUTION NO. 724-2024

ENDORSING TO THE DEPARTMENT OF HEALTH THE APPLICATION FOR A PERMIT TO CONSTRUCT (PTC) A THREE-STOREY BUILDING FOR LEVEL II HOSPITAL WITH A 100-BED CAPACITY AT THE LINGAYEN DISTRICT HOSPITAL, PROVINCE OF PANGASINAN

WHEREAS, the Lingayen District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 2nd District of Pangasinan;

WHEREAS, at present, there is a constant increase in the number of patients being serviced by the hospital and there is a need to accommodate all people especially the less fortunate sector of society;

WHEREAS, the Provincial Government of Pangasinan, through the Lingayen District Hospital, intends to construct a 3-storey building for Level II Hospital with a 100-bed capacity in order to provide the people a sufficient and higher level of medical and health services;

WHEREAS, pursuant to Administrative Order No. 2016-0042, a Permit to Construct (PTC) from the Department of Health must first be secured before the construction of the building to ensure compliance with the guidelines in planning and design of health facilities;

WHEREAS, the Sangguning Panlalawigan deems it necessary to endorse to the Department of Health the construction of a 3-storey building for Level II hospital with a 100-bed capacity at the Lingayen District Hospital in line with the main thrust of the Provincial Government of Pangasinan to provide medical and health services to indigent patients of the Province;

WHEREAS, prior to the issuance of a license to construct, a Provincial Board Resolution is required by the Department of Health to facilitate the issuance of the permit to construct a health facility;

WHEREFORE, on motion of SP Member Shiela Marie F. Baniqued and co-authored by SP Members Philip Theodore E. Cruz and Haidee S. Pacheco, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to endorse, as it is hereby endorsed, to the Department of Health the application for a Permit to Construct (PTC) a Three-Storey Building for Level II Hospital with a 100-bed capacity at the Lingayen District Hospital, Province of Pangasinan;
