**WHEREAS**, one of the visions of the present administration is to strengthen various programs and projects on information and media relations of the Province;

**WHEREAS**, it is the objective of the Provincial Government of Pangasinan to reach wider audience and disseminate information to the public as fast and as accurate as possible by using modern technology;

**WHEREAS**, in order to realize the foregoing goal, the Province of Pangasinan has entered into a contract with the Regional News Group (RNG) Luzon, Incorporated and for almost a year, it has aired on television and social media, and uploaded on other social media platforms 50 full episodes and more than 300 highlight videos, the true beauty and richness of the province, including its historical, traditional and cultural values through the Travel Magazine Show “Ganda Mo Pangasinan”;

**WHEREAS**, in a letter addressed to the Provincial Governor, Ramon V. Guico III, dated June 28, 2024, the Regional News Group (RNG) Luzon, Incorporated, has signified its intention to continue its partnership with the Provincial Government of Pangasinan to help boost the tourism industry of the Province through the Travel Magazine Show “Ganda Mo Pangasinan”;

**WHEREAS**, for the above purpose, a Contract shall be entered into and signed between and by the Province of Pangasinan, represented by Honorable Governor, Ramon V. Guico III; and the Regional News Group (RNG) Luzon, Incorporated, represented by Ms. Joyce Rhen de Guzman, Station Manager;

**NOW, THEREFORE**, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Contract with Regional News Group (RNG) Luzon, Incorporated for the renewal of the provision of broadcasting facilities for the Travel Magazine Show “Ganda Mo Pangasinan”;
