RESOLUTION NO. 728-2024

DECLARING MUNICIPAL ORDINANCE NO. 03, SERIES OF 2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED “AN ORDINANCE STRENGTHENING THE ALLOCATION OF THE APPROPRIATION OF SPECIAL PROGRAM FOR THE EMPLOYMENT OF STUDENTS (SPES) UNDER PUBLIC EMPLOYMENT SERVICES OFFICE (PESO) AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (P500,000.00)” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Municipal Ordinance No. 03, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Republic Act No. 7323, known as the “Special Program for Employment of Students” as amended by Republic Act No. 9574 and 10917; Section 2 of R.A. No. 8759, otherwise known as the “Public Employment Office (PESO) Act of 1999”; Sections 16 and 447 (a) (5) (xiv) of the R.A. No. 7160;

WHEREAS, the Local Chief Executive in coordination with the Municipal Local Finance Committee shall include in the LGU’s Annual Budget for the C.Y. 2025 the funding of P500,000.00 for the implementation of the subject ordinance;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
