### RESOLUTION NO. 730-2024

**APPROVING RESOLUTION NO. 05-24-269 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM 1 (SIP 1) SERIES OF 2024 OF THE LGU MABINI, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Mabini, Pangasinan submitted its Resolution No. 05-24-269 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Mabini, Pangasinan has identified items in their Supplemental Investment Program 1 for CY 2024. This was endorsed to the Sangguniang Bayan on April 30, 2024 through MDC Resolution No. 01, Series of 2024 and was favorably acted upon by the Sangguniang Bayan on May 27, 2024 through SB Resolution No. 05-24-269;
2. The SIP No. 1 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal government offices, and the implementation of disaster risk reduction programs and priority development projects of the LGU;

3. The total investment requirement for the full implementation of the said SIP in the amount of Php 29,752,364.94 will be sourced from the municipality's Supplemental Budget No. 1 CY 2024, amounting to PhP 25,052,364.94, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 1, Series of 2024 on May 27, 2024, Php 2,500,000.00 to fund the Procurement of Ambulance proposed for funding from the national government (DBM) and Php 2,200,000.00 will be sourced from the unexpected balances from CY 2023 LDRRM Fund of the LGU; and
4. However, the proposed programs/projects to be funded under the unexpended LDRRM Fund FY 2023 shall be incorporated in the revised Annual Investment Program pursuant to Section 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, which states: "The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP".

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mabini, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


