### RESOLUTION NO. 732-2024

**APPROVING RESOLUTION NO. 2024-116 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1, CY 2024 OF SUAL, PANGASINAN AMOUNTING TO ELEVEN MILLION SEVEN HUNDRED SEVENTY-FOUR THOUSAND FIVE HUNDRED PESOS (P11,774,500.00)”**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2024-116 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan has identified items in their Supplemental Investment Program (SIP) No.1 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on March 8, 2024 by the Municipal Development Council through Resolution No. 2, Series of 2024;
2. The SIP No. 1 of the municipality covers the Construction and Installation of Solar Streetlights along national road at Paitan, Seselangen and Sual-Eastern Boundary portion of Sual, and the Provision of Medical Equipment to Brgy. Health Centers proposed to be funded from the LGU's share from DOE ER 1-94 amounting to PhP11,774,500.00;

3. The identified programs/projects are consistent with the DOE Department Circular No. DC2018-08-0021 dated July 26, 2018, "Providing for the Amendments to Rule 29 Part (A) of the Implementing Rules and Regulations of Republic Act. No. 9136"; and
4. Funding support is embodied in their proposed Supplemental Budget No. 01 CY 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 02, CY2024 on April 22, 2024 and approved by the Municipal Mayor on May 28, 2024.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;


