APPROVING RESOLUTION NO. 039-2024 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 FOR CY 2024 OF THE MUNICIPALITY OF LABRADOR, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Resolution No. 039-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Labrador, Pangasinan prepared their Supplemental Annual Investment Program (SIP) No. 1 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 001-S-2024 dated June 5, 2024, to the Sangguniang Bayan for approval;
- 2. The Sangguniang Bayan approved said Supplemental AIP through Sangguniang Bayan Resolution No. 039-2024 dated June 10, 2024. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 3. Said Supplemental AIP, which has a total investment requirement of
 ₱25,000,000.00, covers the augmentation of funds for Personal Services
 (PS), Maintenance and Other Operating Expenses (MOOE), and Capital
 Outlays (CO) of some offices of the LGU, and the implementation of
 priority projects of the municipality; and

4. Funding for the implementation of this Supplemental AIP is embodied in the LGU's Supplemental Budget No. 1, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01-2024, dated June 10, 2024, and approved by the Municipal Mayor on June 13, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Labrador, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 039-2024 of the Sangguniang Bayan of Labrador, Pangasinan, entitled "Approving the Supplemental Investment Program No. 1 for Calendar Year 2024 of the Municipality of Labrador, Pangasinan";
