RESOLUTION NO. 736-2024

APPROVING RESOLUTION NO. 276, S-2024 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 AND 2 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) EXECOM THRU RESOLUTION NO. 1 & 2, SERIES OF 2024 AMOUNTING TO SIXTY-SEVEN MILLION, EIGHT HUNDRED FIFTY THOUSAND PESOS (P67,850,000.00) FOR GENERAL FUND AND NINE HUNDRED SEVENTEEN THOUSAND FIVE HUNDRED THIRTY-FOUR AND 67/100 PESOS (P917,534.67) FOR SPECIAL ECONOMIC ENTERPRISE"

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 276, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Bayambang, Pangasinan prepared the LGU's Supplemental Annual Investment Program Nos. 1 and 2 for CY 2024. This was endorsed by the Council, through MDC-ExeCom Resolution Nos. 1 and 2, Series of 2024 dated April 30, 2024 and May 6, 2024, respectively, to the Sangguniang Bayan for approval;
2. The Sangguniang Bayan approved said Supplemental AIP Nos. 1 and 2 through Sangguniang Bayan Resolution No. 276, Series of 2024 dated June 3, 2024. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

3. The Supplemental AIP No. 1, CY 2024 covers the augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay of the different offices of the Municipal Government, and implementation of priority projects of the LGU. The Supplemental AIP No. 2, CY 2024 covers the augmentation of funds for the Personal Services (payment for the additional Representation Allowance and Transportation Allowance (RATA)) of department heads of the LGU; and
4. Funding for Supplemental AIP Nos. 1 and 2, CY 2024, which have a total investment requirement of P68,767,534.67 (GF: P67,850,000.00 and SEE: P917,534.67), is embodied in the LGU's Supplemental Budget Nos. 01 and 02, CY 2024, These were enacted by their Sangguniang Bayan through Appropriation Ordinance Nos. 01 (for the General Fund) and 02 (for the Special Economic Enterprise), both Series of 2024 dated June 3, 2024 and approved by the Municipal Mayor on June 10, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 276, S-2024 of the Sangguniang Bayan of Bayambang, Pangasinan, entitled “Approving the Supplemental Annual Investment Program No. 1 and 2 duly indorsed by the Municipal Development Council (MDC) Execom through Resolution No. 1 & 2, Series of 2024 amounting to Sixty-Seven Million, Eight Hundred Fifty Thousand Pesos (P67,850,000.00) for General Fund and Nine Hundred Seventeen Thousand Five Hundred Thirty-Four and 67/100 Pesos (P917,534.67) for Special Economic Enterprise”;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bayambang, Pangasinan, for its information and guidance.
