RESOLUTION NO. 737-2024

DECLARING SUPPLEMENTAL BUDGET NO. 1 (GENERAL FUND) FOR CALENDAR YEAR 2024 OF BAYAMBANG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P67,822,857.18, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Supplemental Budget No. 1 for CY 2024 involving total appropriations of P67,822,857.18 which was enacted on June 3, 2024 through Appropriation Ordinance No. 01, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its Supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;

3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
4. That the utilization of all appropriation for Capital Outlay shall as may be applicable, be subject to the authorization of the Sanggunian on the list of projects to be implemented as ruled by the Supreme Court in the case of Hon. Gabriel Luis Quisumbing et. al. vs Hon. Gwendolyn F. Garcia, et. al., G. R. 175527, December 8, 2008;
5. That the grant of additional One Thousand Pesos (P1,000.00) in Clothing Allowance to all municipal officials and employees of the municipality for Fiscal Year 2024 shall be in accordance with the provisions of Budget Circular No. 2024-1 dated April 4, 2024 of the Department of Budget and Management;
6. That the appropriation for the payment of Terminal Leave Benefits and Monetization of Leave Credits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re "Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits", which provides for the new constant factor stated under Item 3.1 thereof; and
7. That the grant of increase in Representation and Transportation Allowances (RATA) shall be in accordance with the provisions of Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 1 for Calendar Year 2024 of Bayambang, Pangasinan;


