APPROVING RESOLUTION NO. 24-023(a) OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 02 FOR CALENDAR YEAR 2024 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 24-023(a) to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The City Development Council of San Carlos City, Pangasinan prepared the Supplemental Investment Program (SIP) No. 02, CY 2024. This was endorsed by the Council, through CDC ExeCom Resolution No. 02-24 (Series of 2024) dated March 7, 2024, to the Sangguniang Panlungsod for approval;
- 2. The Sangguniang Panlungsod approved said Supplemental Investment Program through Sangguniang Panlungsod Resolution No. 24-023(a) dated March 25, 2024. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

- 3. The Supplemental Investment Program (SIP), which has a total investment requirement of ₱12,000,000.00, covers the purchase of one (1) unit of Ambulance Vehicle with accessories and equipment, and two (2) units of Ambulance Vehicles (only) for the LGU. The projects are to be funded from the Local Government Support Fund − Financial Assistance to LGU and Support for Capital Outlays and Social Programs, FY 2023 GAA; and
- 4. The proposed projects conform with Local Budget Circular No. 150 dated March 2, 2023 (Guidelines on the Release and Utilization of the Local Government Support Fund-Financial Assistance for LGUs and Support for Capital Outlays and Social Programs under the FY 2023 General Appropriations Act, Republic Act 11936).

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of San Carlos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 24-023(a) of the Sangguniang Panlungsod of San Carlos, Pangasinan, entitled "Approving the Supplemental Investment Program (SIP) No. 02 for CY 2024 of the City of San Carlos, Province of Pangasinan";
