RESOLUTION NO. 742-2024

APPROVING RESOLUTION NO. 24-029(a) OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3 FOR CALENDAR YEAR 2024 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN”

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 24-029(a) to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The City Development Council of San Carlos City, Pangasinan prepared the Supplemental Investment Program (SIP) No. 3, CY 2024. This was endorsed by the Council, through CDC ExeCom Resolution No. 03-24 (Series of 2024) dated April 4, 2024, to the Sangguniang Panlungsod for approval;
2. The Sangguniang Panlungsod approved said Supplemental Investment Program through Sangguniang Panlungsod Resolution No. 24-029(a) dated April 8, 2024. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
3. The Supplemental Investment Program (SIP), which has a total investment requirement of ₱67,524,399.69, covers the implementation of priority projects of the LGU; and

4. Funding support for the implementation of the SIP is embodied in the LGU's Supplemental Budget No. 02-24, FY 2024, which was enacted by their Sangguniang Panlungsod through Appropriation Ordinance No. 24-09 dated April 8, 2024, and approved by the City Mayor on April 10, 2024.




