**RESOLUTION NO. 745-2024**

**DECLARING ORDINANCE NO. 23-51 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING A CONJUGAL ROOM INSIDE THE SAN CARLOS CITY JAIL FACILITY, APPROPRIATING THE NECESSARY FUNDS THEREFOR AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 23-51 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted in line with national policies and principles of the Gender and Development Code of the Philippines enshrined in the 1987 Constitution and in harmony with R.A. No. 7192, “An Act Promoting the Integration of Woman as Full and Equal Partners of Men in Development and Nation Building and for other purposes” and R.A. No. 9710, “Magna Carta of Women”; Sections 16, 17(a)(iv)(4), 22(1)(2)(5) and 458(a)17(xv) of R.A. No. 7160, “Local Government Code of 1991”; and Section 2 of R.A. No. 10575, “Bureau of Corrections Act of 2013”;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 (c) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez, and Raul R. Sabangan, duly seconded, it was—


