RESOLUTION NO. 747-2024

APPROVING RESOLUTION NO. 414, S-2024 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 4 S. OF 2024 TO BE FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 1 CY 2024 AMOUNTING TO TWENTY SEVEN MILLION EIGHT HUNDRED SIXTY THOUSAND PESOS (P27,860,000.00)”

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 414, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Bautista, Pangasinan has identified items in their Supplemental Annual Investment Program No. 4. This was endorsed to the Sangguniang Bayan for approval on April 16, 2024 by the Municipal Development Council-Executive Committee thru Resolution No. 4, S. of 2024 and was favorably acted upon by the Sangguniang Bayan on May 13, 2024 thru Resolution No. 414, S. of 2024;

2. The SAIP covers fund augmentation for the Personal Services/granting of incentive and other personnel benefits), and capital outlay of some municipal offices and implementation of development projects of the LGU; and
3. Funding support for the full implementation of the same in the amount of Php 27,860,000.00 is embodied in their Supplemental Budget No. 1 for CY 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 1, S. of 2024 on May 13, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bautista, Pangasinan;


