RESOLUTION NO. 750-2024

DECLARING MUNICIPAL ORDINANCE NO. 03-06102024 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCCAT – VAWC) OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN AND PRESCRIBING ITS COMPOSITION AND FUNCTIONS, AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 03-06102024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 2 of R.A. No. 9208 or Anti-Trafficking in Persons Act of 2003; Section 2 of R.A. No. 9262 or Anti-Violence Against Women and their Children Act of 2004; R.A. No. 9710 or The Magna Carta of Women; and Sections 16, 17 (a)(vi) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


