APPROVING RESOLUTION NO. 57, S-2024 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1, SERIES OF 2024 (SIP-01-2024) IN THE MUNICIPALITY OF STO. TOMAS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 57, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Sto. Tomas, Pangasinan has identified items for inclusion in their 1ST Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan for approval on April 22, 2024 by the Municipal Development Council-Executive Committee thru Resolution No. 01-SS-2024 and was favorably acted upon by the Sangguniang Bayan on May 13, 2024 thru Resolution No. 57, Series of 2024;
- 2. The SAIP covers fund augmentation for the Personal Services, development projects and other projects in support to the tobacco growing farmers in the LGU;

- The project proposed to be funded from the tobacco excise tax are in accordance with the CY 2021 Collection of Burley and Native Tobacco Excise Tax under RA No. 8240, as amended, Chargeable against the FY 2023 GAA, RA No. 11936; and
- 4. Funding support for the full implementation of the same in the amount of Php 7,809,567.06 is embodied in their proposed Supplemental Budget No. 1 for CY 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 01, Series 2024 on May 13, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sto. Tomas, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 57, S-2024 of the Sangguniang Bayan of Mabini, Pangasinan, entitled "Approving/Adopting the Supplemental Investment Program No. 1, Series of 2024 (SIP-01-2024) in the Municipality of Sto. Tomas, Pangasinan";
