### RESOLUTION NO. 755-2024

**DECLARING MUNICIPAL ORDINANCE NO. 198-270524 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “AN ORDINANCE REQUIRING POOL/RESORT OWNERS AND SIMILAR BUSINESSES TO PROVIDE CERTIFIED LIFEGUARDS AND LIFEGUARDING EQUIPMENT IN THEIR OPERATION AND PROVIDING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWER OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 198-270524 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 447 (1) (iii) (3) (ii) (4) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;


