**RESOLUTION NO. 760-2024**

**DECLARING MUNICIPAL ORDINANCE NO. 2022-04 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “AN ORDINANCE ENACTING THE HEALTH AND SANITATION CODE OF THE MUNICIPALITY OF BOLINAO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Municipal Ordinance No. 2022-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (a) (2) (iii) & (vi), and 447 (a) (1) (iii) & (vi), (4) (i) & (ii) and (5) (xiii) of R. A. No. 7160; R. A. No. 8749 or the “Clean Air Act of 1999”; R. A. No. 9003 or the “Solid Waste Management Act”; R. A. No. 9275 or the “Clean Water Act”; and Presidential Decree No. 856, or “Sanitation Code of the Philippines”;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


