APPROVING RESOLUTION NO. 129, S-2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE SECOND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 129, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Infanta, Pangasinan has identified items in their First Supplemental Annual Investment Program (SAIP) for CY 2023. This was endorsed to the Sangguniang Bayan on June 18, 2024 through MDC Resolution No. 05, Series of 2024;
- 2. The SAIP No. 02 covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of some municipal offices, and implementation of disaster risk reduction and management programs and other priority projects of the LGU with a total investment requirement of PhP12,567,272.00; and

3. Funding support for the proposed SAIP is embodied in the municipality's Supplemental Budget No. 2, CY 2024 amounting to PhP10,767,272.00, which was approved and enacted by their Sangguniang Bayan on July 5, 2024 through Appropriation Ordinance No. 02, Series of 2024. The remaining PhP1,800,000.00 will be sourced out from the DILG-SGLG Incentive Fund.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Infanta, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 129, Series of 2024 of the Sangguniang Bayan of Infanta, Pangasinan, entitled "Approving the Second Supplemental Annual Investment Program (AIP) for Calendar Year 2024 of the Municipality of Infanta, Pangasinan";
