**RESOLUTION NO. 767-2024**

**DECLARING ORDINANCE NO. 24, S-2024 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING SECTION 3 (B) AND SECTION 7 OF MUNICIPAL ORDINANCE NO. 90, S-2020, ENTITLED “AN ORDINANCE HONORING AND GRANTING CASH INCENTIVES TO OCTOGENARIANS, NONAGENARIANS, AND CENTENARIANS IN THIS MUNICIPALITY” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 24, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the power of the Sangguniang Bayan to enact ordinances and approve resolutions carries with it the power to amend, revoke, modify or repeal the same;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 24, S-2024 of the Sangguniang Bayan of Lingayen, Pangasinan, entitled “An Ordinance amending Section 3 (B) and Section 7 of Municipal Ordinance No. 90, S-2020, entitled “An Ordinance honoring and granting cash incentives to octogenarians, nonagenarians, and centenarians, in this municipality” as within the conferred powers of the Sangguniang Bayan to enact;
