APPROVING RESOLUTION NO. 2024-130 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1, CY 2024 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2024-130 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Mangaldan, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 1, CY 2024 of the LGU. This was endorsed by the Council, through MDC Resolution No. 2, Series of 2024 dated June 10, 2024, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental AIP No. 1, CY 2024, which has a total investment requirement of ₱3,038,243.00, covers augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some offices of the LGU and implementation of priority projects of the municipality; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 1, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-01 dated June 21, 2024 and approved by the Municipal Mayor on July 5, 2024. It is respectfully recommended, however, that projects/activities to be funded from the 20% Development Fund, 5% LDRRMF, GAD and PPAs for Children be identified/specified, and be included in the succeeding Supplemental AIPs of the LGU.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2024-130 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled "Approving and Adopting the Supplemental Annual Investment Program (AIP) No. 1, CY 2024 of the Municipality of Mangaldan, Pangasinan";
