APPROVING RESOLUTION NO. 2024-39 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 2024-01 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2024-39 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Binalonan, Pangasinan has identified items in their Supplemental Annual Investment Program No. 1. This was endorsed to the Sangguniang Bayan for approval on April 26, 2024 by the Municipal Development Council-Executive Committee thru Resolution No. 01-2024;
- 2. The SAIP covers fund augmentation for the Personal Services (Granting of Incentive and Other Personnel Benefits), Maintenance and Other Operating Expenses (MOOE), and Capital Outlay of some municipal offices and implementation of development projects of the LGU; and

3. Funding support for the full implementation of the same in the amount of Php 125,146,821.15 is embodied in their Supplemental Budget No. 1 for CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-01 on May 3, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binalonan, Pangasinan;
