APPROVING RESOLUTION NO. 2024-102 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (SAIP) NO. 2 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF LAOAC, PANGASINAN AMOUNTING TO EIGHTEEN MILLION SIX HUNDRED THIRTY- FIVE THOUSAND FORTY-NINE PESOS (P18,635,049.00)"

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 2024-102 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Laoac, Pangasinan has identified items in their 2nd Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan for approval on March 21, 2024 by the Municipal Development Council-Executive Committee through Resolution No. 2024-02;
- 2. The SAIP covers fund augmentation for Capital Outlay of improvement of infrastructure projects in support to tobacco growing farmers of the LGU with a total investment requirement of Php 18,635,049.00 to be funded from the shares of the LGU from the tobacco excise tax;

- 3. The projects proposed to be funded from the tobacco excise tax are based on the CY 2021 Collection of Burley and Native Tobacco Excise Tax under RA No. 8240, as Amended, Chargeable against the FY 2023 GAA, RA No. 11936; and
- 4. Funding support for the full implementation of the same is embodied in their proposed Supplemental Budget No. 2 for FY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-002 on April 29, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Laoac, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2024-102 of the Sangguniang Bayan of Laoac, Pangasinan, entitled "Approving the Supplemental Annual Investment Plan (SAIP) No. 2 for Calendar Year 2024 of the Municipality of Laoac, Pangasinan amounting to Eighteen Million Six Hundred Thirty- Five Thousand Forty-Nine Pesos (P18,635,049.00)";
