APPROVING RESOLUTION NO. 228-06182024 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "AUTHORIZING THE REVERSION OF APPROPRIATIONS FOR CONTINUING APPROPRIATIONS (UNDER THE GENERAL FUND AND 20% MUNICIPAL DEVELOPMENT FUND) OF LGU POZORRUBIO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 228-06182024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution:

WHEREAS, the funding support for the full implementation of the same are sourced from the reversion of appropriation under General Fund and 20% Development Fund and unappropriated Surplus/Savings is embodied in their proposed Supplemental Budget No. 1 for CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01-06182024 on June 18, 2024 and approved by the Municipal Mayor on June 20, 2024;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Pozorrubio, Pangasinan;


