**APPROVING RESOLUTION NO. 229-06182024 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “APPROVING THE FIRST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2024 FUNDED BY THE UNAPPROPRIATED SURPLUS/SAVINGS AND REVERSION OF APPROPRIATIONS FOR UNFILLED POSITIONS AND CONTINUING APPROPRIATIONS OF LGU POZORRUBIO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 229-06182024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Pozorrubio, Pangasinan has identified items in their 1<sup>ST</sup> Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan for approval on May 27, 2024 by the Municipal Development Council-Executive Committee through Resolution No. 01-2024. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991; and

2. The SAIP covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, Capital Outlay, and implementation of disaster risk reduction program of various municipal offices and the implementation of priority development programs and projects of the LGU.


