**APPROVING RESOLUTION NO. 16, S-2024 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "APPROVING RESOLUTION NO. 2, S-2024 OF THE SAN QUINTIN MUNICIPAL DEVELOPMENT COUNCIL'S (MDC) EXECUTIVE COMMITTEE ON THE REVISED ANNUAL INVESTMENT PROGRAM CY 2024 INTEGRATING THE CY 2024 QUICK RESPONSE ADDITIONAL PROGRAM, ACTIVITIES AND PROJECTS (PAPs) FOR THE PREPAREDNESS MEASURE FOR THE EFFECTS OF EL NINO"**

**WHEREAS**, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 16-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Disaster Risk Reduction and Management Council through MDRRMC Res. No. 01, Series of 2024, prepared their Supplemental LDRRM Plan CY 2024 to utilize the unexpended balances from LDRRMF CYs 2021 to 2023 in the amount of PhP7,800,000.00;
2. The Local Development Council revised their AIP 2024 to include the new projects from the Supplemental LDRRM Plan and endorsed the same to the Sangguniang Bayan for approval on March 14, 2024 through MDC Res. No. 02, Series of 2024. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

3. The preparation of the Revised AIP is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote: 6.5. The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP; and
4. Said projects are consistent with NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013 "Allocation and Utilization of the LDRRMF" and DILG Memorandum Circular No. 2023-065 "Mitigation and Preparedness Measure for the El Niño Phenomenon" dated April 25, 2023.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Quintin, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
