**PROVINCIAL RESOLUTION NO. 786-2024**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A RENEWAL OF MEMORANDUM OF UNDERSTANDING WITH THE CULTURAL CENTER OF THE PHILIPPINES FOR THE CONTINUOUS ESTABLISHMENT OF PARTNERSHIP FOR THE KAISA SA SINING (KSS) REGIONAL ART CENTER IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, Kaisa Sa Sining (KSS) is a partnership program of the Cultural Center of the Philippines (CCP) with local government units in order to establish a growing network of regional art centers;

**WHEREAS**, in 2018, the CCP has identified the Province of Pangasinan as one of its partners in the implementation of the said program;

**WHEREAS**, the Sangguniang Panlalawigan has authorized the then Provincial Governor to enter into and sign a Memorandum of Understanding with the CCP and there is a need now to renew the same;

**WHEREAS**, the continuous establishment of partnership between CCP and the Province of Pangasinan will eventually result to further enrichment, development and promotion of arts and culture in the region and the country;

**WHEREAS**, the key areas of the partnership include training and apprenticeship opportunities; touring and move-over productions; sharing of relevant cultural resource materials; access to arts and cultural information, venues and facilities; promotion of major cultural events/activities of the province in media platforms; and participation in major cultural events;

**WHEREAS**, the Memorandum of Understanding shall cover a period of three (3) years from 2024-2026;
